### **NOTICE INVITING QUOTATIONS (NIQ)**

Invitation of Quotations for Supply and Installation of Blinds/Roller Blinds at State Institute of Rural Development Meghalaya.

Sealed quotations are invited from reputed and registered firms/suppliers for the supply and installation of blinds/roller blinds at the State Institute of Rural Development (SIRD) Meghalaya, Nongsder, Ri Bhoi District - 793103. Interested firms meeting the eligibility criteria are requested to submit their quotations as per the details provided below:

### 1. Scope of Work

- Supply and Installation of Blinds/Roller Blinds for various rooms/offices at SIRD, Meghalaya.
- Types of blinds required: Roller Blinds (Blackout and Light-Filtering), (as per specifications).
- Locations: Administrative Building (Establishment Office), Training Halls (Training Hall 3 and Hall 1) Conference Room and Computer Lab.
- Approximate quantity: 22 windows
- Includes measurement, supply, installation, and post-installation support.

### 2. Eligibility Criteria

- The bidder must be a registered firm/company with a valid GST registration certificate.
- The bidder should have a minimum of 3 years of experience in supplying and installing blinds/roller blinds for government institutions, PSUs, or reputed organizations.
- The bidder must have a valid PAN card and Trade License.
- The bidder should not be blacklisted by any government organization.

## 3. Technical Specifications

- Material: High-quality PVC, fabric, or wooden blinds as per requirement.
- Type: Roller Blinds: Blackout (light-blocking) and Light-Filtering (translucent).
- **Operation**: Manual (chain/cord-operated) or motorized (optional, to be quoted separately).
- Colour and Design: To be finalized after sample approval by SIRD authorities.
- Warranty: Minimum 2 years on material and installation.
- Fire Resistance: Blinds should comply with fire safety standards (certification required).
- **Installation**: Must include fitting, alignment, and testing.

### 4. Submission of Quotations

- 1. Format: Quotations should be submitted in two parts:
  - Technical Bid: Containing company profile, experience certificates, copies of GST, PAN, Trade License, and compliance with technical specifications.
  - Financial Bid: Containing item-wise rates, including supply, installation, taxes, and any other charges.
- 2. **Sealed Envelopes**: Both bids should be placed in separate sealed envelopes marked "Technical Bid" and "Financial Bid" and enclosed in a single sealed envelope superscribed with "Quotation for Supply and Installation of Blinds/Roller Blinds SIRD Meghalaya."

- 1. Rates should be quoted per square foot or per unit, inclusive of all taxes, transportation, and installation charges.
- 2. Payment Terms:
  - o 50% advance on confirmation of order.
  - o 30% after supply and installation.
  - o 20% after satisfactory completion and inspection.
- 3. Validity of Quotation: Rates should be valid for at least 90 days from the date of submission.

#### 6. General Terms and Conditions

- The selected supplier must complete the work within 15 days from the date of issuance of the work order.
- SIRD reserves the right to reject any or all quotations without assigning any reason.
- Any defective material or poor workmanship will be replaced/repaired free of cost by the supplier.
- The supplier must ensure minimal disruption to SIRD operations during installation.
- Bidders may visit the site for measurements and assessment before submitting quotations (contact the undersigned for coordination).
- Any dispute will be subject to the jurisdiction of Shillong, Meghalaya.
